### > Brief industry overview

The prospect for the South African raisin industry remains positive for the future. The South African industry has grown sharply and new expansions and recapitalisation initiatives are ongoing to further grow our supply base.

The following salient figures for industry are summarised below:

- SA is internationally recognised for producing top quality raisins;
- Annual raisin production is approximately 80 000 dried metric tons;
- Produced roughly by 700 growers;
- World class processing facilities;
- 85% of all product destined for international markets;
- Industry turnover estimated at R2bn.



#### Raisins SA Cost Guide

The annual cost guide for the raisin industry in South Africa was released in October 2019 for the first time.

If we say 'to measure is to know' then we must have our own measure available.

In total 500 hard copies has been distributed amongst our grower members, financial institutions and input providers to our industry, on an annual basis since 2019. We also send out electronic versions to everybody on our distribution data base.
